### Response rate and status of cases reported at RAC in the year 2020

As the year 2020 comes to a close, we would like to share with you the status of cases reported to RAC in the year 2020, and the response rate by duty bearers/stakeholders in each of the district where we operate.


As seen from the charts below, the response rate by the duty bearers to cases reported by RAC has greatly improved. This can be attributed to a number of factors including;

a. The trust built between RAC and the duty bearers, this trust has been strengthened as a result of the evidence-based reports produced by RAC. RAC tries as much as possible to do due diligence for all cases reported to ensure that justice prevails
b. The wide range of platforms for stakeholder engagement has also strengthened our partnerships and collaboration with the duty bearers. We now look at each other as partners who need one another for improved service delivery in the Rwenzori region

c. Transparency exhibited in information sharing has further strengthened our collaboration with the state agencies. Sharing of reports/issue papers ahead of our meetings and; provision of written responses to issues raised has also minimized room for error and false allegations
d. RAC's commitment to leave no stone un-turned when it comes to case follow up and logical conclusion of all cases reported has earned us credit and as such, all stakeholders find RAC a credible institution that is worth working with It is our plea to the state anti-graft agencies to always

expedite action and conclusion of cases brought to their attention to avoid demotivating the whistle-blowers who raise a red-flag whenever they site cases of corruption in society.

# Highlights of activities conducted in the Quarter under review

Governance cluster Joint Monitoring Visit to Kasese - October 23, 2020

On October 23, 2020, members of the governance cluster made a trip to Kasese in a joint learning/monitoring visit. The visit emanated as a proposal from one of the governance cluster reflection meetings. The Governance cluster members from Kasese had on several occasions failed to turn up for the governance cluster meetings and therefore, members found it prudent to make a courtesy call to understand why this was happening.

In addition, Kasese as a district had been hit by floods and grossly affected by COVID 19. To extend our compassion and solidarity to our governance cluster partners in Kasese, members resolved to visit the team in Kasese.

Further still, RAC as the host for the governance cluster had received reports from some of the whistle-blowers (RAC monitors) in Kasese who had written to RAC, alleging that they were being harassed for reporting cases of corruption to RAC. The board therefore resolved that they make a follow up visit to interact with these monitors not only to understand and address their concerns but also show solidarity and appreciation for the monitors' commitment to fight against corruption. Also, the communities of Kasese as a district have for a long time been faced with several challenges including tribal clashes, land conflicts, epidemics like Ebola and COVID, and floods among others. The governance cluster, together with selected members from the RAC board therefore decided to pay a courtesy call to these communities, some of whom had lost their loved ones and property.

The visiting team was represented by members of the governance cluster and selected members of the RAC board.

In Kasese, the team visited some CSOs that seek to promote good governance and other like-minded organizations based in Kasese including RWECO, Good Hope and KALI. These had expressed interest in becoming members of the governance cluster. The team also interacted with some of the RAC monitors.

#### **Courtesy Call at RWECO**

This was the first stop-over...here the visiting team was received by Masereka Earnest – the Finance and Administrative Officer for RWECO. Mr. Masereka on behalf of his Executive Director who was away in Kampala for official duties welcomed the team and expressed his appreciation to the Governance Cluster for the courtesy call.

Mr. Masereka made a brief presentation about RWECO's profile, highlighting their programs and area of operation.

#### **Meeting with KALI**

KALI is a member organization of RWECO and as such, the visiting team paid a courtesy call to KALI to know more about their programs and how the cluster can pattern with them to promote good governance in the Rwenzori region.

Jimmy Odyek – a board member of KALI informed us of some of the governance programs they conduct as KALI. These include;

- Transparency and social accountability
- Gender Advocacy
- Peace and conflict resolution
- Human Rights Advocacy
- Environmental conservation and policy advocacy

#### Interface with the election Observers

A brief meeting with the election observers was also made to get a feel of the electoral processes in the district, while at the same time understand the challenges they face in executing their duties as election observers so as to come up with strategies to address the identified challenges.

Key among the challenges identified include;

- Long distances moved when executing their duties
- Harsh weather conditions that makes it difficult to

In the meeting, Angela Byangwa, the Executive Director – Rwenzori Anti-Corruption Coalition (RAC) introduced the visiting team, highlighting the purpose of the visit...

She pointed out that some of the governance cluster members are election observers but unfortunately, some (RAC monitors) had been arrested while performing their duty. She said that as CSOs, we are there to support government in promoting good governance and therefore, it is not right to arrest citizens when performing such noble duties.

In response, the DISO cautioned the governance cluster and all CSOs at large to desist from employing persons who are actively involved in politics.

By and large, the DISO said that Kasese as a district is prone to disaster but they have a disaster plan in place to manage the different forms of disaster that befall the district.

In conclusion, the DISO appreciated our visit and thanked us for the support accorded to the district. "CSOs are doing a great job and government needs them..."

monitor especially during the rainy season.

To address the above challenges, they recommended that RAC fundraises for more resources to equip them with motor bikes – considering the fact that Kasese is a mountainous, area, it is not easy to move up the mountains on foot or by means of public transport

The monitors also requested for protective gears like umbrellas, gum-boots and rain coats to enable them monitor even on a rainy day.

#### Visit to Kilembe Mines Hospital (old premises)

Early this year, Kasese district was hit by floods that destroyed property and lives of people. The governance cluster therefore paid a visit to one of the areas that was worst hit by the floods i.e. Kilembe Mines hospital.

It was shocking to see that what was formerly a large hospital was no more. All the structures were swept away by the floods with nothing to show that this area was once a hospital land.

From our visit, we were informed that the hospital had been relocated from Kilembe to Kasese municipality.





It was on this note that the governance cluster resolved to give gift hampers to the new mothers and neonates at Kasese Municipal Health Center III during the commemoration of the 2020, Anti-Corruption Week, as proof of our sympathy to the affected communities.

### **Commemorating the Anti-Corruption Week 2020**

The Anti-Corruption Week (ACW) is an advocacy week celebrated nationally and internationally; it is a week that was set apart to decry the evils of corruption, demand for accountability and cause action against the corrupt. Every year, Rwenzori Anti-corruption coalition (RAC) joins the rest of the world to commemorate the Anti-Corruption week (ACW) as a drive to support the 'Zero tolerance to corruption policy' by the Government of Uganda.

This year, due to the outbreak of the COVID19 Pandemic, commemoration of the 2020 Anti-Corruption Convention was conducted at district level with small numbers of participants, observing the SOPs from the Ministry of Health to prevent the spread of the disease, under the theme: Promoting Social Accountability through Active Citizenry'

A total of 8 district-based conventions were conducted across the eight districts of the Rwenzori region i.e.

Bundibugyo, Ntoroko, Kabarole, Kamwenge, Kyenjojo, Kyegegwa, Bunyangabu and Kasese. The conventions provided a platform for RAC to present some of the pending cases for response and action by the responsible duty bearers. Also, the conventions provided a platform for the district leaders i.e. District Chairperson, RDC and CAO to renew their commitment to the fight against corruption in the region.

Also, RAC awarded each of the eight district Local Governments certificates of recognition in appreciation of their commitment to the fight against corruption.

In attendance were various participants including IAF members i.e. Office of the Inspector General of Government, Director of Public Prosecution, Office of the Auditor General and the Directorate for Ethics and Integrity. Other participants included; RDCs, District Chairpersons, Chief Administrative Officers (CAOs) DPCs, DISOs, different Heads of Department, Members of the Governance Cluster, the Media Fraternity, the RAC board, Staff and Monitors among others.

#### Key immediate outcomes

a. Response, clarification and updates on cases presented during the convention

- b. Commitments to expedite action upon the cases reported to the IAF
- c. Strengthened relationship and collaboration with the IAF at national level
- d. Renewed commitment to fight against corruption by leaders and key stakeholders at the district level

e. The convention further provided a platform for the wider community to raise pertinent service delivery issues for response by the respective duty bearers

f. All the 8 district-based conventions were aired live on different local FM stations for the wider community to participate. In addition, the

proceedings of the convention were streamed live on Facebook and zoom.

All the eight district local goverments where RAC works were awarded certificates in recognition of their support to the fight against corruption in the Rwenzori Region.

In addition, leaders of these districts i.e. the District Chairperson, RDC and CAO signed and renewed their commitment to the fight against



### In Brief... other activities conducted in the Quarter under Review...

#### The RAC Annual General Meeting...

On October 30, 2020, the General Assembly of Rwenzori Anti-Corruption Coalition converged at their office premises to take stoke of the year 2019. The AGM that was meant to be conducted in the month of April was postponed to October due to the outbreak of the COVID19 pandemic across the globe. It is for this reason that this time round, participation of monitors and other stakeholders was limited to a smaller number, as required by the Ministry of Health Standard Operational Procedures SOPs to minimize the spread of the Corona virus.



Nevertheless, the meeting was successfully conducted, with some new members elected to join the board of Directors i.e. Kakooza John as the new District Coordinator of Kyenjojo/Kyegegwa District and Constance Koom as the new district coordinator of Kasese district. The rest of the Board members retained their positions.



#### The Voter Education project...

Rwenzori Anti-Corruption Coalition in partnership with the Civic Education Coalition in Uganda, (CECU) with financial support from the Democratic Governance Facility (DGF) is implementing a voter education program in the 9 districts of the Rwenzori region i.e. Kabarole, Kamwenge, Kasese, Bunyangabu, Ntoroko, Bundibugyo, Kyenjojo, Kyegegwa and Kitagwenda. The project seeks to contribute to the realization of a Free and Fair elections 2021, through empowering communities to exercise their civic and political rights.

Through various civic and voter awareness campaigns, the project seeks to equip citizens with knowledge on their rights so as to effectively task and engage those vying for different political positions to address their concerns (citizens charters) in exchange for their votes. A number of activities have thus been implemented including; Radio talk shows on voter education, voter education sessions for the community for mass awareness creation, live broadcast and radio, debates for candidates that are vying for various political positions and training of trainers (voter educators) to massively sensitize the masses on voter education among others. It is anticipated that at the end of the project, the citizens will be in a better position to make informed decisions in as far as electing their leaders is concerned.

#### **Meeting with interest Group Members:**

A total of eight interest groups were met across the eight districts of the Rwenzori region where RAC operates. The meetings offered a platform for the interest groups to air out their concerns, which were presented to leaders for redress during the District Integrity Promotion Forums. The groups met include among others; youth in school and out of school, youth leaders, women leaders, women groups, elderly and PWDs

#### **Round table meetings:**



A total of 63 round table meetings were conducted across the 63 sub-counties of the Rwenzori region, bringing together a total of 1343 participants i.e. 884 male, 410 female & 49 undisclosed sex, 52 elderly, 151

youth, 1116 adults & 24 undisclosed age, 22 PWDs, 1321 Non-PWDs. In this quarter, each round table meeting had a target of 22 participats. From the round table meetings, a total of 535 cases were presented to the leaders for response, out of which 87 were responded to and concluded while the remaining 225 were referred to District Integrity Promotion Forum for response by leaders/duty bearers at the district level. The round table meetings provided aplatform for sub-county leadership to hear, respond, clarify and act on issues reported by the citizens. RAC has been appreciated by the leaders for providing this space for engagement with the citizens on accountability issues



**Follow up of cases reported by monitors:** A total of 203 cases reported by monitors were followed up in the quarter under review, and the response obtained was communicated to the citizens during the 63 community feedback meetings held.

A total of 8 social audits were conducted across the eight districts of RAC's operation in the Rwenzori region. During the social audit, a total of 16 projects were jointly monitored by RAC and the district officials including members of DPAC, District Chairpersons, RDCs, DISOs, District councilors, Internal auditors, Procurement officers, CAOs and the media. The social audits have been used as a tool to prevent loss of funds during project implementation. Through site visits with duty bearers, CAOs have directed contractors to correct defects on some of the projects monitored at their own (contractor's) cost.

**Focal persons attend council sessions:** All the 8 District Focal Persons attended various meetings within their respective districts and submitted reports to the secretariat for follow up on salient issues. A total of 22 reports were submitted by the district focal persons in the quarter under review, with updates on assignments conducted and cases followed up with respective duty bearers. The focal persons have been able to mentor the other monitors in case follow up and at the same time keep RAC updated on the status of cases reported to the duty bearers. The focal persons further attended council sessions and technical meetings to track accountability by the duty bearers at the district level.

**Monitoring Visits:** A total of 80 monitoring activities were undertaken by 462 monitors and 218 activists. From the monitoring activities, a total of 80 evidence-based reports were submitted with 203 issues. Out of the issues reported, 87 were corruption related issues, 17 Human rights ,99 service delivery gaps were raised for response, follow up and action by the respective duty bearers. The issues raised were presented to the respective duty bearers for response during round-table meetings and District Integrity Promotion Forum meetings. RAC has been able to monitor government services amidst COVID19 pandemic and ensured that communities comply with the Ministry of Health SOPs

Mobilize communities to participate in sub county planning and budgeting meeting with parish representatives. RAC participated in 63 budget conferences and obtained lists of priorities identified at each sub-county. These were printed and disseminated to various candidates vying for various political offices to commit/ensure that once voted into office, they will endeavor to see to see that these are realized.



**District Integrity Promotion Forums:** A total of 8 DIPF meetings were conducted in the quarter under review, bringing together a total of 368 participants i.e. 235 male, 93 female, 40 undisclosed sex, 30 elderly, 27 youths, 308 adults, 3 undisclosed age, 362 Non PWDs and 6 PWDs. From the 10 DIPFs conducted, a total of 307 issues were presented to the leaders for response, out of which 166 were responded to and concluded, while the remaining 141 were responded to but are still under investigation.

# **Change stories**

### JUSTICE AT LAST... RAC'S SUPPORT EARNS JUSTICE FOR THE **COMMUNITY OF BASE CAMP IN KASESE DISTRICT**

The community of the Red Cross Area of Base camp in Kasese district will forever be grateful to RAC for their commitment, assistance and determination that enabled them win the case against those that had erroneously sold their land for their own selfish gain ...

It all started way back in the year 2008 when Alex Katikiro, while being employed as Acting Senior Lands Management Officer Kasese District Local Government In search for justice, the affected wrote to the Commissioner land registration indicating that Kasese District Land Board had granted Muthegeki John Muhindo a freehold land measuring 1.272 instead of 0.60 hectares along base camp road, an act which was prejudicial to the interest of his employer.

According to the then Assitant CAO and Secretary Land board for Kasese District Local Government, Mr. Muthegeki John applied for a piece of land and the board approved to the applicant freehold land of 0.695 hectares. However, Mr. Katikiro communicated to Mr. Muhindo and the Commissioner Land Registration that the board had approved 1.272 hectares and therefore should go ahead and process a land title for the

applicant. The title was thus secured in the names of Mutegeki John Muhindo using the board minutes that that had approved the size of 0.695 hectares.

In the year 2010, Mr. Mutegheki sold the land in question to Prakash Ganatra, leading to the eventual eviction and demolition of property of the community land.

community ran to the courts of Law to file their case; a criminal case no. HCT -00-AC-CO-033-2016 was opened against Alex Katikiro.

Although the case was filed, investigation and conclusion of this case was so slow hence delaying justice.

It's at this point that the affected community reported their dissatisfaction and concerns to RAC, seeking for their help to have their case expeditiously concluded. Following their plea, the RAC monitors of Kasese Municipal Council dug up the case and established that it was lying in the Anti-Corruption Court. The monitors lobbied several relevant offices to ensure that the case comes up for

hearing. Among other things, the monitors at some point provided transport means and on other occasions traveled to Kampala as witnesses to the case to ensure that justice prevails.

On November 13, 2020, the monitors' sweat yielded beautiful fruits... after several sessions of hearings and submission of evidence, the accused – Mr. Katikiro that was residing on this piece of Alex was sentenced to a 3 year and 8 month imprisonment, in addition to disqualification from public office for a period of Ten years. Hadn't it been for the commitment of the RAC monitors that did everything within their powers to ensure that the case is brought for hearing, the affected community would probably never have lived long enough to attain justice.

## At long last

For a very long time, RAC has been engaging various offices and duty bearers for justice and logical conclusion of the case in which one –Zhao Long – the owner of Good Home Super Market in Fort Portal was arrested by police over possession of government stores. During the search, ten Mama kits were recovered each being sold at 50,000 (Fifty Thousand shillings Only). A case was registered at Fort Portal police vide SD REF NO.32/19/03/20 and case reference number CRB 340/20 (Illegal possession of Government stores). The suspect called Zhao Long was arrested and detained at the said police station but later given bail.

To RAC's dismay, the RSA failed to


prosecute the suspect, asking him to bring the person who sold to him the kits. The investigating officer said that when they tried to review the CCTV camera to see who had supplied them, it was found that the camera had been tampered with so they could not track the person who delivered the kits in question. Such circumstances were therefore delaying the logical conclusion of this case and as such setting a bad example for others out there who are or are likely to engage in such unscrupulous behaviour.

RAC could not rest until this case was accorded all the investigations and justice deemed necessary. She therefore brought it to the attention of several stakeholders and players including the District

Integrity Promotion Forum, Director of Public Prosecution, IGG and the Directorate of Ethics and Integrity among others.

Owing to the pressure mounted by RAC, the file was recalled and court hearings resumed...on December 13, 2020, Mr. Zhao Long was brought before court for hearing. Though not yet concluded, we at RAC and other justice-loving citizens are optimistic that once found guilty and charged, others elsewhere with similar intentions of robbing government stores will desist from engaging in such illegal acts - to the benefit of the citizens for which such items are intended.
