SOME CASE STUDIES OF RAC'S ADVOCACY WORK.

RAC Information & Advocacy Officer

Since its inception in 2001, RAC's secretariat working with the relevant offices in its area of operation, have received and worked on a number corruption cases. The coalition is so far the best and first whistle blower in as far as the fight against corruption is concerned.

Its first and beat impact has been awareness creation which has helped to create fear among public officers who handle public finances.

The secretariat's tribute goes to individuals and the coalition's monitors at all levels who despite the death threats from the corrupt-minded people have continued to volunteer giving corruption-related information.

And as a result, so many civil servants have either been interdicted or made to refund the embezzled money. RAC's nine year's intervention in the campaign against corruption has brought about discipline in public offices and places of work, a case in point being in the health and education sectors.

Given the fact that corruption is a cancer that has eaten deep into people's bone marrows the secretariat is saying 'aluta continua' and is calling on any rightful thinking Ugandan to join the struggle. Its (RAC's) tribute also goes to offices of the Chief Administrative Officers (CAOs), Resident District Commissioners (RDC's), Inspector General of Government (IGG) the Auditor General (AG), police, Local Governments and legal Aid.

Other helpful offices which deserve special tribute include Local Councils, Courts and Civil Society Organizations. These offices have always ensured that cases are followed up to logical conclusions.

The public need to note the RAC never begrudges or witch hunts anybody but it's mindful of the standards of living of the poorest of the poor who are most times voiceless.

The coalition's methods of work are transparent because whenever reports are received they are critically analyzed to pick corruption or suspected corruption issues.

RAC's advocacy officer then reaches out to the respective/concerned offices in writing in order to be certain about the raised issues. To remove any room for doubt, RAC even after writing to the concerned offices, makes face-face follow ups.

In cases of community projects the coalition reaches out to the CAO and the Sub County authorities through dialogues.

Here are some of the case studies RAC has since followed up and acted upon to logical conclusions;

Musandama Primary School funds misappropriated.

Reports from Musandama Primary School in Karugutu Sub County, Bundibugyo District have indicated that money worth shs 2,425,925 million was misappropriated.

The information was revealed by one of the teachers of Musandama Primary School who doubles as a member of the school finance committee.

The teacher disclosed that the money was compensation funds paid to the school by UGASURV, the road surveyors working on the Fort Portal-Bundibugyo road. According to the teacher the money was received by three members of the School Management Committee led by the chairperson Mr Mono Richard.

The reports further indicate that the members had impersonated as owners of the school land in question.

RAC officials learnt that upon receiving the money, the three shared it amongst themselves and only handed over a small fraction to the head teacher.

RAC visited the school and discovered that indeed the money was misappropriated by the alleged officials.

After RAC's visit the head teacher promised to convene a meeting to address the matter.

A meeting comprising of the School Management Committee Members, founder body, PTA and other relevant stakeholders was called and the accused persons were tasked to explain and ordered to refund the money. The accused admitted having taken the money and asked for apology promising to refund the money.

In the end shs 951,450 was recovered and banked on the school account for the intended school use. More follow up is being made and there is hope that all the money will be recovered. Below is an appreciation letter to RAC from the School head teacher.

Mismanagement of Funds at Mbuga Primary School

Acting on the complaints raised by Mbuga primary school PTA executive, School Management Committee, teachers and some parents to RAC monitors in Kasenda Sub County, RAC followed up a case of mismanagement of funds by the head teacher of the school Mrs. Harriet Kabagambe.

RAC monitors followed up the issue and compiled a report which they shared with RAC secretariat. The secretariat wrote and followed up the matter with the Chief Administrative Officer and District Education Officer who agreed that they were aware of the situation and accordingly promised to take action.

The CAO requested RAC to take a more active role to unearth more details about the allegations of mismanagement of funds and abuse of office by the head teacher.

The findings revealed that the head teacher had misused UPE and other school funds worth shs 8 million without accountability and where some accountability was done the procedure for spending the funds was grossly flawed.

It was also discovered less collaboration between the head teacher and other stakeholders including teachers resulting in the teachers' low morale, increased absenteeism and the poor academic performance.

The findings also revealed that the management of the school was for long been up hazard. Like there was never formal hand over by outgoing head teachers to the incoming ones.

This loophole had created a situation where

new head teachers kept heaping blame on their predecessors for lost funds.

After the follow up, RAC compiled a report of her findings and recommendations for the auditing the of Mbuga Primary School books of account, meeting of parents and school management committee bodies and shared the recommendations with the CAO, DEO and the school head teacher.

This report caused a meeting of stakeholders at the school in which the head teacher was tasked to explain why public funds were being mismanaged.

The District also made a special audit of the school and found out that indeed shs 8 million had been mismanaged.

Finally District authorities interdicted the head teacher and promised to ensure that handover ceremonies are seriously taken into account when a new head teacher is assuming office.

During the 2009 RAC-Ruteete/Kasenda Sub County conference, the Chairperson LCIII Kasenda and members of Mbuga Primary School management committee told participants that classrooms would be reconstructed and that funds worth shs 36 million re-allocated from ADB project would be used for plastering, flooring and shutting.

This kind of revelation showed how communities, foundation bodies and other stakeholders can own monitoring of their developmental projects and put Government to task.



RESEARCH IN HEALTH AND EDUCATION REVEALS SHOCKING RESULTS

Research carried out in September 2009 in health and education by Rwenzori Anti corruption Coalition (RAC) in Rwenzori Sub Region has revealed that service providers are partly to blame for the poor health services and education standards in the region.

Government and the communities in general are also to blame for the poor education and health services in the region.

This was revealed by a mini- research/ monitoring in the Ruwenzori region conducted by RAC monitors in the region with support from Ms Uganda.

The Monitor's results can't be disputed because they did the research after a thorough training on what to look out for when monitoring the sectors.

The monitoring was conducted in 60 schools (both primary and secondary) and in 30 Health Centers in the Region.

It was conducted in the five Districts of her operation with particular focus on the education and health sectors.

The purpose of the monitoring was to find out key challenges in these sectors and then identify strategies of how they can be addressed to ensure that services are taken down right to the beneficiaries.

It was also aimed at fighting corruption and causing improved/better service delivery to the community.

RAC in its vision and mission emphasizes the saying "Health is wealth and education is knowledge"

Its objectives are therefore not fulfilled if or when people's right to health and education and, to wealth and knowledge are denied by some service providers.

It was however discovered in the research that some people can't afford to access these services due to lack of information or money.

The monitoring helped in unearthing a number of issues/challenges where some stood out to be common challenges all over the region.

Sources of the revelation range from Head Teachers, in Charges of health centers, nurses, teachers, pupils, parents, patients, casual laborers in the monitored institutions to observation.

RAC in this issue brings you some of the key issues that were discovered in the health and education

sectors during the monitoring;

Health.

RAC Monitors discovered a lot of absenteeism among the health workers, and it is one of the major contributing factors to poor health services in the region.

It was also discovered that health workers contribute to poor health services by stealing drugs, being rude to patients, by reporting late to their health centers and by making patients wait for too long before they are attended to.

It was also discovered that most health workers do not work during weekends and hide information like budgets, patient's attendance lists and some are reluctant to report the short comings to the relevant authorities.

The monitor's findings show that Government is another contributor of poor health service delivery.

This happens when Government fails to put place all the necessary facilities like staff houses, placenta pits, kitchens and the logistics like fuel and vehicles for easy movement of the workers.

The discoveries also reveal lack of deep freezers, lack of water at some health centers like is the case at Mucwa Health Centre II, delayed delivery of drugs to the health centers from the National Medical stores and delivering expired drugs or unwanted ones.

Low salaries and allowances, failure to send health workers for further studies, few wards, and poor pit latrine coverage at health centers, lack of electric power, inadequate staff and lack of hand washing facilities are some of the Government's weakness in the improvement of health services.

The research did not exonerate the communities as the contributors of health service delivery in the region. It was discovered that HUMCs do not supervise health workers, monitor the distribution of drugs, ask for books of accounts from the doctors/in charges and some patients prove to be stubborn to health workers leading to unnecessary collusions attacks.

Education.

Failure to adhere to the professional code of conducts or teachers' ethical standards is one of the reasons why there is poor service delivery in education, as teachers keep on complaining instead of working first.



Other problems that were discovered in education by RAC monitors that lead to poor education include absenteeism, lack of control of pupils by the teachers, lack of proper schemes of work, forgeries, misappropriation of UPE funds, inadequate learning aids and the teacher's failure to complete the syllabus.

The monitors discovered further that by failure to construct enough classrooms and staff houses, raise teachers' salaries, put in place enough furniture, political influence, poor pit latrine coverage and non functional water tanks, Government directly or indirectly contribute to poor service delivery in schools. Government is to blame for the poor services because of its failure to replace the transferred teachers, recruit enough teachers and providing facilities like libraries, laboratories and employing enough health workers to regularly attend to the sick pupils or students.

Parents or the communities contribute to poor services in schools by failing to follow up their children to find out if they real go school, stay there and study.

The community's other contributing factors include failure to provide their children with packed lunch, doing or helping their children to do home work and failure to give enough scholastic materials.

CAN WOMEN TOO FIGHT CORRUPTION?

Many people have faced intimidation and death threats from the wealthy and corrupt individuals thus shying away from the fight. Women are the biggest contributors to development, yet the biggest victims of corruption.

RAC in all her activities has endeavored to engender her fight against corruption by bringing on board all categories of people in the society regardless of gender. RAC has built their capacities to monitor, report, lobby, advocate and cause positive change in the society.

Below TRACK brings you experiences of some of the female anti-corruption activists in the region.

I joined RAC in 2005 after realizing that corruption was too much in Karugutu Sub County. As an anti corruption woman activist, I have come to realize that the anti corruption crusade needs to begin with the individual at family or house hold level.

Joining the anti-corruption crusade group as a gender representative on the RAC Executive Committee in 2006 has given me chance to voice out my anticorruption message in the Rwenzori region.

My husband and I have started educating our children about the dangers of corruption and how it affects the community.

Am fighting corruption at family level by being transparent and honest in all what we do at home and discouraging the children from participating in corrupt tendencies at school, like bribing pupils for votes or teachers and class monitors to give them favors, let alone dodging school or classes.

Using drama groups like Karugutu Women Association and Karugutu Tukwatanize Group, I have sensitized my fellow women about the ills of corruption and have brought a good number of Karugutu women on board in the fight against corruption.

As RAC secretariat we have developed a Gender concept that caters for mainstreaming gender issues in the fight against corruption.

More women and special groups have been trained, enriched with anti-corruption messages and also have been involved in several anti-corruption activities/ crusade.

However the fight is not a bed of roses, as it comes with many challenges like loss of time, community ignorance, reluctance or fear of some key witnesses to come up and testify against some corruption cases.

As a teacher and anticorruption activist in Kasese town council I have a lot of experiences in the fight against corruption in my community.

We people in the anti corruption crusade are the development engines of this nation and in order to live up to this expectation we need to be

serious as the fight against corruption is a tough venture.

In most cases public servants, business people, parents and children have consciously or unconsciously found themselves misusing power/resources entrusted to them for personal gains.

At family level husbands refuse to be open to their wives about their financial status thinking it's not an obligation.

Women too secretly ensure that they squeeze and save from the little monies given to them by their husbands for family needs. At family level there is favoritism among the parents which creates divisions and hatred amongst the children. And this is the worst form of corruption at family level, but unfortunately most people do know it.

In schools, corruption is practiced by failing to manage time, favoritism of pupils, dodging classes, and non accountability of school funds, bribing fellow pupils with money and sweets during elections.

During my class room lessons and interactions with children I take time to explain to the pupils in simple terms the forms of corruption and how it can be fought or avoided.

From my constant 'preaching' I have realized that most teachers have learnt to manage time and ensure that all lessons are taught as planned.

However the biggest challenge I still find is with police officers who kill the defilement cases that are reported to them by conniving with the defilers.

Never the less, the struggle still continues, and appealing to the mothers out there to join this fight because as mothers they interact with many people.

Women potential fighters of corruption given their God-given soft nature and convincing tongue which am sure can cause positive change in our region.

COMMUNITY EMPOWERMENT; A Solution to Corruption

As her core programming area, RAC has been undertaking a number of capacity building activities for her members, stakeholders and the general community.

In doing this, the coalition has been able to enhance skills and capacity of these people and to also promote civic competence.

Capacity building has helped RAC in building a strong task force for fighting corruption in the region. This is evidenced by the actions being taken against corrupt officials by Government and the concerned citizens.

Under its capacity building programmes, RAC has conducted several trainings to enhance/equip her monitors, the community and the local leaders with different skills and knowledge on how to effectively fight corruption.

The coalition in November 2009 conducted 30 branch trainings across the region which were attended by 400 monitors.

The trainings were intended to educate the Community Process Facilitator and the monitors on what to look out for when monitoring education and health sectors, for instance the enrollment and retention of pupils in schools, performance and sanitation.

RAC's other major concerns have been the relationship between stakeholders and the institution, the performance of Health Unit Management Committees (HUMCs), Parent Teachers Associations (PTAs), Finance committees and School Management Committees (SMCs), attendance of health workers and accountability of funds among others.

A number of short falls were discovered through monitoring as a follow up tool used in ensuring effective delivery of services in schools and health centres.

It (monitoring) was done in sixty schools and 30 Health Centers across the region where a number of issues like absenteeism, non accountability of funds, non functionality of HUMCs, PTAs, and SMCs were discovered.

Others issues are poor relationship between schools and the community or founder bodies, understaffing, inadequate funding, delayed delivery of drugs, frequent stock outs, lack of support from parents to their children and the school.

Poor sanitation and hygiene, poor supervision by the



head teachers, In-Charges and Sub County leadership were the other issues that were unearthed.

The monitoring discovered that it was pertinent that RAC conducts Sub County conferences to address these issues.

Thirty Sub County conferences were conducted and over 500 people who included RAC members, health workers, teachers, community leaders and Sub accountants participated.

The purpose of the conferences was to create a plat form where the community can interface with their leaders/ service providers to share corruption challenges in their areas.

During the conference issues like absenteeism, poor or non accountability of funds, non functionality of HUMCs, PTAs, and SMCs and poor relationship between schools and the community were discovered.

Others problems shared included lack of support from founder bodies, and poor supervision by the head teachers, In-Charges and Sub County leadership.

The conferences helped in bringing to light the existing service delivery challenges in the community and identifying solutions to the challenges like stopping absenteeism and late coming.

Trainings for head teachers, SMCs, PTAs, and Finance Committee chairpersons in the Districts of Kabarole, Bundibugyo, Kyenjojo and Kamwenge were also conducted with the purpose of orienting and reminding the participants of their roles and responsibilities.

During the trainings participants were taken through Principles of Management, elementary issues in finance management, roles and responsibilities of PTAs, SMCs and finance committees, and the minimum requirements/guidelines.

Over time RAC has grown into a big and trusted anti graft fighting body in the country and can now be consulted and used to conduct trainings across the country

One such training was conducted in September 2009; it was for Mid Western Region Anticorruption Coalition (MIRAC) in Hoima at Kijungu Hill hotel.

The purpose of the training was to share with MIRAC, RAC's best practices registered in the fight against corruption.

MIRAC members from the Districts of Kibale, Masindi, Hoima, and Buliisa attended the training.

The participants appreciated RAC's concern in enhancing MIRAC's capacity in the fight against corruption and also identified modalities of how to take on monitors.

RAC also conducted five radio talk shows facilitated by Ms Uganda, one in each District to address corruption issues in the health and education sectors.

Common forms of corruption in the education sector and helping the different committees in schools in curbing corruption were some of the issues shared during the talk shows. Issues of absenteeism, non accountability and mis use of UPE funds, poor supervision of schools authorities, forgery of academic documents, and political influence came up.

Others issues included non-payment of teacher's salaries, ghost teachers and pupils, shoddy works and construction of school buildings.

KICHWAMBA INTEGRITY AMBASSADORS CLUB AND CORRUPTION!

As a sign of seriousness against corruption, RAC has gone ahead to involve students in the fight.

Uganda Technical College Kichwamba (UTC-K) is one among the many institutions that have declared its readiness to fight corruption.

With support and guidance from the office of the IGG, Kichwamba technical college formed an anti corruption club called Kichwamba Integrity Ambassadors club.

UTC-K integrity ambassadors club was recently launched at the college. It has caused vigilance amongst the college administrators and the students towards the fight against corruption.

The club passes it information through skits and poems carrying anti- corruption messages.

Kichwamba Integrity ambassadors club mainly advocates for justice and equality for all mankind. It also teaches people how to handle corrupt situations and persons.

In some of her recent interventions, the club has registered positive impact on the moral conduct and attitude change within the communities.

However in all her works the club faces a lot of resistance, insults and challenges like rigidity and reluctance of some members to change their positive perception about corruption to negative.

In conclusion therefore there is need to collectively fight corruption.

RAC News At A Glance

Kamwenge District officials nabbed in NAADs scam

Ntara Sub County chief, the sub accountant and the District NAADS Coordinator are alleged to have embezzled around shs11 million.

Whereas the internal audit report indicates shs 11 million, the external audit report reveals shs19 million.

The trios were in December arrested and prosecuted. He also appeared before court and bailed after paying a fine of shs 2 million. The NAADS Coordinator paid back shs 5 million.

The Sub County chief was remanded to katojo Government prison while the sub accountant is still on the run.

The Mayor Fort Portal Municipal council decries corruption in land board

The Mayor Fort Portal Municipal council Mr Edison Abasa Ruyonga has decried corruption in the District land board and called on central Government investigates it.

He cited an example of two plots one in Boma and another near the bus and lorry pack which were fraudulently sold by the Kabarole District land board. He says that one of the plots is a green belt

The plots were reportedly sold to Baguma crescent, one of the local invenstors through corrupt tendencies.

An impromptu council meeting was on January 5. In the meeting RAC was selected on the sub committee to investigate the matter. More details about this matter are yet to come out.

RAC and media join hands to fight corruption.

RAC and the journalists from the Rwenzori region have joined hands in the fight against corruption.

The commitment of the two bodies was made in December 2009 during meetings with the media across the region.

Journalists had for long been partnering with RAC to expose corruption in the region. It was observed in the meetings that the media need to be more organized for self regulation.

Key challenges like limited professionalism, unhealthy competition, and limited involvement/cooperation

of District Information Officers with the media were high lighted.

Others challenges included conflict of interest; serving the interests of the proprietor and the public, greed and selfishness by some journalists and poor facilitation.

The meeting was aimed at mapping strategies on how the two can best work together to kick corruption out of the Rwenzori region.

In these meetings it was resolved that different media houses need to organize themselves into associations if they must succeed in their fight against corruption.

RAC holds its Annual General Meeting (AGM)

On 24/July 24, 2009, RAC held her AGM at Gardens restaurant which was attended by 106 members. The participants included RAC monitors, staff and BoD, RDC Kabarole and the RAC patron.

The meeting re-elected Alex Ruhunda as patron and also recommended that RAC's next AGM be held in March 2010.

Kasese public expenditure audit conducted

RAC staff and monitors in conjunction with the District water officer, Kasese carried out a verification exercise in Kasese District in September 2009.

The purpose of the exercise was to find out value for money especially in Government funded water projects intended to benefit the community.

RAC visited Kiyebe, Mahango and Kikorongo Gravity Flow Schemes, the rehabilitated boreholes under UNICIEF in Muhokya, Rukoki and Kasese town council.

RAC also visited protected water springs under UNICIEF in Kitswamba, Kyabarungira, and Bugoye sub counties.

Problems like shoddy construction works, and non functional projects were discovered.

Members of RAC also visited and appreciated well done projects.

Understaffing, staff absenteeism and Abscondment, stock outs, non functional Health Unit Management Committees (HUMCs) have been identified as some of the problems hindering service delivery in the health sector in the Rwenzori Region.

This was on August 2009 disclosed by the executive chairperson RAC, Mr. James Mwirima, during a dissemination meeting held at Kenneth Inn in Fort Portal town.

The meeting was organized to disseminate and share RAC's health research report with her key stakeholders.

The stakeholders included District Health Officers, District CAOs, and the media drawn from the Rwenzori Region.

The meeting was proceeded by a press briefing, which was attended by V.O.T FM, Life FM, Better FM, Guide RADIO, Messiah radio, Grace Radio, New vision and Monitor Correspondents.

RAC procures bicycles, digital cameras.

RAC procured Hero bicycles, digital and still cameras. The items were distributed to RAC branches across the region.

The RAC regional Coordinator Ms Angela Byangwa says that the items are meant to beef up and facilitate the branches' monitoring work.

RAC has also procured 15 Notice boards for installing in the Sub Counties of her operation.

Anti Corruption Week 2009

The 2009 anti-corruption coalition's week which attracted all regional anti corruption coalition from the country was this year celebrated in Soroti District, Eastern Uganda.

The theme of the week was 'Improving Governance and Accountability in the water sector in Uganda'

The week's celebrations started with the launch of the book of Shame and Fame at Sheraton hotel on 09.12.09.

It was followed by a public debate at Serena hotel on 10.12.09, a procession and public dialogue in soroti at Soroti independence square on 11.12.09.

Shoddily constructed water points in Kumi District, Mukorongo Sub County were visited as one of the activities of the week.

The week brought out challenges/corruption tendencies in the water sector like incomplete construction of water points, non functional water points, lack of community ownership of water points and sensitization about development programs.

The RDC Bundibugyo presided over the national celebrations. He represented the Minister of state for Water, Hon. Jessica Aliyo.
